BACK GROUND CHECKS

The ECFOA has hired an outside company to handle our background checks. This will be for all Division 2/3 and supplemental officials. We are now up and ready to proceed. There are directions in the next paragraph on how to go about it. If needed, you will have a person to assist you and their name and number is at the end of this e-mail.

Please know that no one will have access to your information except myself and Dennis Crim. This will enable us to confirm that you have completed the requirements for the background checks.

The instructions are as follows:

First, you will need to establish an account whether you have existing clearances or not.

Begin with www.backgroundmanager.com and click "start background check".

Use organization code ecfoa and enter information as prompted.

You now have established your account. Once your account is established and if you have completed documents, then download them according to directions. If not, then follow the directions to get your newer updated ones.
